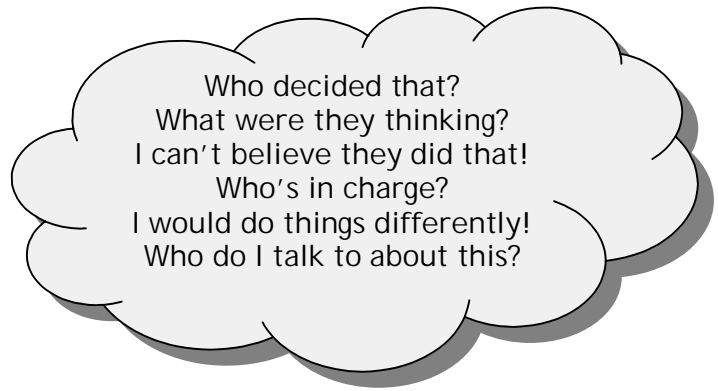





HAVE YOU EVER CONSIDERED BEING A LEADER FOR YOUR INDUSTRY?

The Nominating Committee is looking for potential candidates for next year's Board of Directors, to serve a two year term. Now is your opportunity to put your name forward to be considered as a nominee for the 2012-2013 Board and be a part of the decision-making process.

Each candidate must be willing to perform to the best of his or her ability the following tasks if elected:

- ◆ Serve a 2-year term
- ◆ Attend 75% of board meetings each year either in person or via teleconference (Approximately 6-8 meetings per year)
- ◆ Actively recruit sponsors
- ◆ Recruit at least 3 new members
- ◆ Attend and recruit at least 2 others to attend all Association functions.
- ◆ Solicit from colleagues at least 6 auction items (total minimum value \$1,500)

Although no definitive standards have been established, past members of the Board have possessed the following intangible credentials:

- ◆ Membership for at least 2 years in the Association
- ◆ Exhibits track record of professionalism and integrity within the industry and community
- ◆ Consistent service to the hospitality industry
- ◆ Record of success and achievement
